

Agreement for Services and Release of Liabilities

This agreement is entered into and between Wanderlust Canine Services LLC and _____ (Owner) on _____(Date) for canine daycare services of _____ (Name of dog). Owner represents that they are the legal owner of the dog(s) named above. By initialing and signing this agreement, owner assumes all risk, dangers and responsibilities of dog(s) while the dog is at Wanderlust Canine Services LLC, including any resulting in harm.

Initials ____ All dogs must be healthy, and current on the following vaccinations: **Rabies, Distemper, Bordetella, Leptospirosis, and Canine Influenza.** The Bordetella vaccine must have been given at least 10 days prior to any daycare stay with us if it is done via needle. If it was done through the nose, 3 days must be given before attending daycare. You will be required to bring a copy of your dog’s updated vaccination records from your vet before you start daycare with us to ensure your dog’s safety as well as the safety of our other guests.

Initials ____ All dogs must be free of external parasites. Owner will be immediately contacted to pick up their dog if their dog shows symptoms of external parasites.

Initials ____ All dogs must have a yearly fecal test. If at any point the fecal test is positive, Owner must provide proof of treatment and a negative fecal test prior to returning dog(s) to daycare.

Initials ____ If Owners dog becomes ill, injured or if state of the animal’s health otherwise requires professional attention, Owner gives Wanderlust Canine Services LLC permission to, at the sole discretion, engage the services of a local veterinarian and provide appropriate medical attention to the animal without prior consent of the Owner. The Owner shall be solely responsible for payment of any expenses resulting from treatment. By using our facility, Owner is waiving any claim for injury or illness experienced by owners dog while in the care of Wanderlust Canine Services LLC.

Initials ____ Owner is aware and understands that by leaving owners dog at Wanderlust Canine Services LLC, or any other pet facility, they are at a higher risk of contracting canine cough (kennel cough), viruses, or acquiring nicks, cuts and possibly punctures from interacting with other dogs. Canine cough is similar to the flu in humans and, while all dogs in our care are vaccinated, no vaccination is 100% effective. We maintain a very high level of cleanliness but interaction with other dogs carries with it inherent risks. Owner will be immediately contacted to pick up their dog if their dog shows symptoms of canine cough or any other contagious illness.

Initials ____ Owner agrees that neither Wanderlust Canine Services LLC nor its employees, staff, or volunteers shall be held liable for any injury, illness, death or escape of owner’s dog provided that reasonable care and precautions are taken. Owner releases Wanderlust Canine Services LLC, it’s employees, staff and volunteers from liability of any and all kind arising from or resulting from owner’s dog attending Wanderlust Canine Services LLC.

Owner releases, indemnifies, and agrees to hold Wanderlust Canine Services LLC harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Wanderlust Canine Services LLC. Owner acknowledges and understands that there are certain risks involved canine care, including, but not limited to, dog fights, dog bites to humans and/or other pets and the transmission of disease. With Owner's signature below, owner understands the risk involved in putting owners pet in a multi-dog environment and acknowledges and accepts exclusive and sole responsibility for all medical expenses to said pet no matter the cause. Owner also authorizes the release of said pet's medical records from pet's veterinarian. By signing this contract and leaving pet with Wanderlust Canine Services LLC, Owner certifies to the accuracy of all information given about the pet. Furthermore, Owner hereby certifies that Owner has read and understands this Agreement for Services and Release of Liabilities and all procedures and policies included herein. By signing this Agreement Owner agrees to be bound by its terms and conditions.
